

DISPOSAL OF OLD VEHICLE

1. Sealed tenders in the prescribed Tender form in sealed cover is invited from the interested particulars for the purchase of **ONE OLD VEHICLE UP65 W 3046 Model-Toyota Qualis on AS IS WHERE IS BASIS** lying in this office.
2. Parties interested in the purchase of the above-mentioned vehicle may inspect it on any working day from 26.02.2020 between 10.00 A.M. to 05.00 P.M. at Weavers' Service Centre, Varanasi. This vehicle will be available for inspection up to 17.03.2020 only.
3. The disposal of vehicle shall be strictly on **AS IS WHERE IS BASIS** and no guarantee or certificate of its worthiness or equality will be given by the Department.
4. Tender documents can be obtained personally from this office i.e. Weavers' Service Centre, Varanasi or downloaded from the website of O/o Development Commissioner for Handlooms www.handlooms.nic.in.
5. Tender form should be signed in ink by the authorized signatory only. Photocopy or unsigned tender or tenders not signed by the authorized signatory shall be rejected.
6. **EMD amount of Rs.10000/- (Rupees Ten Thousand Only) is payable by means of Demand Draft in favour of "The Pay and Accounts Officer, RPAO, Ministry of Textiles, New Delhi. Payment by cheque, cash shall not be accepted.**
7. The tender with the following documents and EMD in a sealed envelope should reach the Deputy Director (W), Weavers' Service Centre, IIHT campus, Chowkaghat, Varanasi 221002 within 21 days from the publication of the short notice i.e. on 26.02.2020 by 03.00 P.M. The cover should be super scribed as **"QUOTATION FOR DISPOSAL OF VEHICLE UP65 W 3046"** in bold capital letters.
 - i. Highest price bid in Annexure.
 - ii. Demand Draft for Rs.10,000/- towards EMD.
 - iii. Copy of this document duly signed on each page by the authorized signatory.
8. The cover be dropped in the Tender Box kept in the Administration Section of the Weavers' Service Centre, IIHT campus, Chowkaghat, Varanasi 221002 or sent by speed post/ Registered post to "The Deputy Director, Weavers' Service Centre, IIHT campus, Chowkaghat, Varanasi 221002" and must reach by 3.00 P.M. on 17.03.2020.

9. The tender received on or before 3.00 P.M. on 17.03.2020 for the above vehicle shall be opened on the same day i.e. 17.03.2020 at 5.00 P.M. The bidder or their authorized representative (not more than one) may witness the Tender Opening at the centre. In case if the tender is not opened on the same day due to official exigencies of other reasons, the date will be intimated.
10. The highest offer of the vehicle will be treated as successful tender provided the same is above the reserve price and accepted by the competent authority of this office.
11. If the highest quoting firm fails to honor the bid, the contract with highest bidder will be cancelled & its EMD will be forfeited.
12. The successful bidder will be required to deposit the total bid amount by means of Demand Draft in favor of **"The Pay and Accounts Officer, RPAO, Ministry of Textiles, New Delhi"** within three working days from the date of acceptance of the offer. If the bidder of the successful tender fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.
13. The bidder shall be required to enclose documentary evidence in support of residential status (Aadhar Card/Voters Identity Card/Pan Card in case of individual and Registration Certificate in case of firms etc.) with the Annexure. The bidder is required to give his/her full name, name of the authorized signatory of the firm, name of father, full postal address, telephone number/mobile number in the annexure.
14. The sold vehicle will be removed by the successful bidder(s) within 48 hours of depositing the money at their own expenses after that a penalty of Rs.500/- per day will be levied. No assistance/transportation will be provided by this department. Permission to take out the disposed of vehicle from the premises of Weavers' Service Centre, Varanasi will not be given on holidays, Saturdays and Sundays etc.
15. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his/her name at his/her own cost expeditiously. This office will not be responsible for any lapse on his/her part in this regards.
16. EMD of the successful bidder(s) will be released only after the realization of sale proceed amount and after successful completion of the sale process. No representation in this regard shall be entertained by this department. EMD amount will not be adjusted in the sale amount accepted by this department.
17. The Competent Authority in this department/organization reserves the right to withdraw any items or lot and to reject any/all of the tenders fully or partially or cancel the disposal of vehicle at any stage without assigning any reason thereof.
18. Disputes, if any, shall be subject to jurisdiction in the Court of Varanasi District Court Only.
19. Tendering firm shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
